Dear Pastor V.P Singh,




Dear Mr. Surendra Lal,

You are working in Services Association of Seventh Day Adventist PVT. LTD. It is a company and not a religious organisation. Therefore kindly provide me the following information by 30<sup>th</sup> November 2018. If you do not provide the information you are asked, then you will be responsible for my next legal action.

1. Why are you doing religious work when your SDA Organisation is registered in company act?
2. As per your records by June 30<sup>th</sup> 2017 you have converted 45,974 Hindus to Christians. Have you informed honourable D.M of Varanasi?  
Have you taken Affidavits of their willingness that they want to be Christians? If yes, then provide Xerox copies of each Affidavit.
3. As per your records you are having 32 churches. Are these churches registered? What is the membership of each church on church register?
4. Since, you are having 45,974 members, what is the weekly offering of the churches and total offering of each month? Are you paying tax from the money your SDA company is earning every month from these 32 churches? What do you do with this money? Explain with authentic proof.
5. Your SDA company is registered in India, then why do you send the reports of the people you convert from Hindus to Christian to USA?  
(General conference of SDA 12501 Old Columbia Pike Silver spring MD 20904-6600 USA).
6. Provide the location of all the 32 churches along with the Xerox copy of their registration certificate.
7. How much money have you received so far to convert 45,974 Hindus to Christians from USA? How many Hindus you are planning to convert again?

Remember by 30<sup>th</sup> November 2018 you have to provide all these information.

Dear Mr. Surendra Lal,

On **15/11/2018** I had written a letter and had asked you some genuine information regarding the conversion of **46,405** Hindus to Christians, and remainder of the same on 21/11/2018, but you did not provide the following information so far. You are working in a private company named **Services Association of Seventh Day Adventist Pvt. Ltd.** If your baptism's report of **46,405** is genuine then send me the following information by **30/01/2019**

1. How many Pastors and Preachers are working with you and how much salary you are paying to each pastor for the work of baptism? Does the SDA company follow the wage scale set by the government of India?
2. Regarding conversion of Hindus to Christians, have you taken the permission from the Honourable DM of Varanasi? Have you taken affidavits from them and showed to the honourable DM of Varanasi?
3. Has SDA company taken permission to conduct conversion programs in India?
4. How many villages have you covered so far, and what is the average SDA membership of these villages? Send the names of all the villages and of the SDA members in each village.
5. You have 32 churches, are these churches registered? Provide the **Xerox copy** of their registration certificate. Also membership of each church on church register
6. Why do you send convert reports to USA (General Conference of SDA 12501 Old Columbia Pike Silver Spring MD 20904-6600 USA) how much

money have you received so far from USA to convert 46,405 Hindus to Christians.

If you have been sending false reports of baptisms and evangelisms to procure money from SDA company and grab the post which you are on right now.

Then you have second option:- write down an apology on your current letterhead and resign from your post and send it to the executive secretary of NIU of SDA and CC to:-


