We do not directly show the governing documents, conflict of interest policy, financial statements, or Form 1023 on the website. We will work to make more of the documents directly available (as Form 990 is now) without request.

Form 990, Part IX, Line 11g - Program expense: Payments to writers, editors, monitors of articles, columns 72,159; Adventist Today Sabbath Seminar (ATSS) videos and hosts 4,080; Design, edit, print, mail journal 35,001; Internet expense for ATSS and online articles and comments 10,537; Miscellaneous 1,078. Fundraising expense was 22,437 for printing envelopes and letters, and mailing fundraising materials and receipts.

Form 990, Part XII, Line 1 - In 2022, we reduced donations by the GiveSmart commissions and yearly charge, reasoning that donations were added just to cover the commission. In 2023, we showed both total commission and total GiveSmart charge, but we are not restating the 2022 figures because the netting was 5,915, less than 2 percent of revenues or expenses, and would not change any ratios significantly.
